CMC had done electrical survey, everything was found to be in good condition apart from the car park lights. Geoff Logan arranged for week commencing 13th November to put up temporary lighting.

5. Reports

5.1. Trust Meeting Report. No report received but SM had received Trust minutes for website and noticeboard.

5.2. Finance. GD presented finance reports for September and October. September opened with a balance of \pounds 37,584.55 and closed at \pounds 35,041.33, October opened \pounds 35,041.33 and closed at \pounds 35,484.39.

Concern was expressed over the way a large number of this year's beer festival glasses had not been used. It was agreed to produce purchase

request form to prevent similar future occurrences; any request to spend hall money must be passed by Hall Management Committee first. Also noted that a number of new keys had been purchased.

Concern expressed that hall income was dropping and that the events were not bringing in large amounts of income. Wedding receptions were discussed as a possible source of extra income.
