2. Apologies. Declaration of interests. Apologies, L. McKay; no declaration of interests.

3. Previous minutes and matters arising

Car Park Signs: project cancelled.

Business Stream: further action required. Meeting acknowledged that there was need to have a contract with someone. GD and SM to action.

4. Reports

4.1. Trust Meeting Report

A Trust meeting was held in January, minutes not ready yet. A loan has been made to the Pit Stop Trading Company. A legal agreement has been drafted but not finalised.

4.2. Finance

Opening balance for month £36,199.28, closing £35,454.09.

Room hire commercial and clubs are apparently incorrect. More people using the gym since Christmas. Events ticket sales of £405 for Burns' Night, but noted that no invoices received for Burns' Night or January catering [*at time of meeting*]. Current bank balance about £31,000.

4.3. Admin

4.3.1. Staff Holiday Cover, etc.

Cover required for SM on holiday to check emails, *etc*. MC can check emails but not provide desk cover as she is working during the day. No decision made. Noting Douglas Campbell was taking holiday the week following the meeting.
